Legislative Updates — Travis Lindley stated he met with Chairman Cooper on HB 1013 and was advised that her House Health and Human Service Committee would be ready to take up this bill in about a week. Travis shared that there is a hearing at the Senate Health and Human Services Committee this Wednesday, 2/9/22 with CSBs providing testimony that a small group will be discussing post today's PIP Meeting. The Psychiatric Advanced Direct has passed through the House of Representatives and is now at the Senate. The Senate won't take it up until post Cross-Over Day on March 10th. Robyn Garrett inquired about any movement on HB 1057. Travis stated that it had been assigned to the House Health and Human Services Committee.

Behavioral Health Reform and Innovation Commission – Cindy Levi informed members that there were no further updates since her report at the November 10th Board Meeting.
