

Legislative Day 4

The Georgia General Assembly 2019 legislative session convened for the first legislative day on Monday, January 14th. Newly elected Governor Brian P. Kemp was sworn in shortly after 2:00 pm Monday and preceded back to the Capitol to send off Governor Deal and First Lady Deal. Governor Kemp gave his State of the State address on Thursday morning laying out his vision for the State of Georgia.

Some highlights:

- \$3,000 pay raise for teachers
- \$69 million plan in the amended budget for school security
- Creation of a GBI gang task force
- \$1 million plan to craft state flexibility options for Medicaid
- \$8.4 million in additional funding through APEX
