GOVERNMENT &amp; PUBLIC AFFAIRS UPDATE</b>	Devin Krecl reported the following highlights: <ul style="list-style-type: none"> <li>• Legislative Day 20 was on 02/13/2024</li> <li>• CSB Day at the Capitol was successfully held on 02/13/2024</li> <li>• HB 1077 (Georgia Board of Health Care Workforce; grant program to provide funding to eligible institutions for additional behavioral health workforce training positions) currently sits in House Rules Committee</li> <li>• SB 480 (Georgia Board of Health Care Workforce; student loan repayment for mental health and substance use professionals serving in certain capacities)</li> <li>• AFY24 budget is moving quickly, and Senate will be hearing the budgets in the next week</li> <li>• CSG team continues to monitor HB 883, which has already passed out of the House and have moved on to the Senate, the I/DD Innovation Commission, and the EMPATH Units legislation.</li> </ul>
